- 1. Application, Hold Harmless Waiver, Rules and Requirements Form, and Vendor fee must accompany the application to the committee for your application to be considered. Checks can be made payable to: Ravenna Balloon A-Fair.
- 2. Vendors are required to check in at the front gate (Gate 1) for space assignments.
- 3. If vendors have any questions/problems during the event report to the information desk (located at RV).
- 4. The Ravenna Balloon A-Fair timeline is as

follows:

Saturday:

-Vendor set-up time: 12:00pm - 2:30pm.

\*\*\*Vendors must have their vehicles unloaded and parked in the designated Vendor parking area by 2:30pm.\*\*\*

Event time: 3:00pm - 11:00pm\*

-Vendor tear down: 11:00pm - 12:00am (optional)

## Sunday:

- -Vendor set-up time: 9:00am 10:30am
- \*\*\*Vendors must have their vehicles unloaded and parked in the designated Vendor parking area by 10:30am.\*\*\*
- -Event time:11:00am 6:00pm\*
- -Vendor tear down: 6:00pm 8:00pm
- \*Event end time and vendor tear down time subject to change.

Ravenna Balloon A-Fair Sunbeau Valley Farm Booth Participation Rules and Requirements September 16-17, 2023

# Spaces:

- 1. Outdoor spaces are 10' x 10' in areas designated by the committee, at the site of the Ravenna Balloon A-Fair, Sunbeau Valley Farm.
- 2. Each Vendor is responsible for the set-up, tear down, and manning of their space(s). Vendors will have their space(s) manned for the duration of the event, unless otherwise directed or approved by committee personnel.
- 3. Tents/Canopies must be weighted and staked down on each leg to prevent tip over in case of high winds or storms. Each leg must have a minimum of 30 pounds attached to it. Any vendor not meeting this requirement will be asked to take down their tent.
- 4. The Ravenna Balloon A-Fair only provides marked spaces to vendors. The Ravenna Balloon A-Fair does not supply tables, tents, chairs, stakes, weights, water, or any other such items to vendors. These are the vendor's responsibility.
- 5. If selling any food items they must be properly sealed, packaged with all ingredients listed. The sale of beverages is not permitted from any display or craft booth.
- 6. Booths will remain up during the duration of the event. No vehicles are permitted on event grounds while the event is ongoing. Vendors who tear down early and bring a vehicle on the event grounds without the expressed permission of the Ravenna Balloon A-Fair committee will not be allowed to show at following Ravenna Balloon A-Fair events. If you have any questions, please speak with the Balloon A-Fair craft show booth coordinator or committee member at the event.
- 7. No electricity will be provided for Craft Vendors.
- 8. The Ravenna Balloon A-Fair has exclusive rights for the sale of lighted/glow items such as glow sticks, necklaces and mouth pieces, fiber optics, LED and lighted battery operated novelty items. No vendor will be permitted to sell these or similar items.
- 9. The Ravenna Balloon A-Fair has a strict No-Refund policy.

# RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT SEPTEMBER 16-17th,

HEREBY RELEASE, WAYES, DISCHARGES, AND COVENANTS NOT TO SUE THE RAVENNA BALLOON A-FAIR, INC., its officers and members; officials, agents or any other person or entity working in conjunction with the RAVENNA BALLOON A-FAIR, INC., all for the purpose herein referred to as RELEASES, all liability to the undersigned, its personal representative, assigns, heirs, and next of kin for all loss or damages, and claim or demands therefore, on account of injury to the person or property herein caused by negligence of RELEASES or otherwise while the undersigned is participating in the RAVENNA BALLOON A-FAIR, INC. in any manner.

HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS AND RELEASES each of them from any loss, liability, damage, or cost they may incur due to the participation of the undersigned, its agents or others working in conjunction with it, in or upon the designated area of the RAVENNA BALLOON A-FAIR, INC., and whether caused by the negligence of the RELEASES or otherwise: and
- 3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE due to the negligence of the RELEASES or otherwise while participating in the RAVENNA BALLOON A-FAIR, INC., and while setting up booths, working, observing or otherwise participating in such event.

EACH OF THE UNDERSIGNED further expressly agrees that the forgoing Release and Waiver of Liability and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the law of the State of Ohio, and that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVERS OF ALL LIABILITY AND

INDEMNITY AGREEMENT, and further agrees that no oral representation statements or inducements apart from the foregoing written agreement have been made.
